#### **ABOUT US**

Implementing these projects' activities requires ground transport, which is the reason for this call.

#### **PURPOSE AND OBJECTIVE**

The African Institute for Health and Development seeks to engage qualified service providers to provide car hire services in the Coastal region, more specifically, Mombasa, Lamu, Kwale, Taita Taveta, Tana River, and Kilifi.

#### **SCOPE**

The company/ service provider is required to meet the following requirements:

- i) A well-reputed company providing car hire services and should be able to provide vehicles, including 5-seaters and 7-seaters, in the Coastal region.
- ii) The company must have efficient and effective logistics and communication channels and related documentation.
- iii) The company should be flexible and ready to provide vehicles in different categories, as requested.
- iv) The company should be flexible and able to provide vehicles when requested.
- v) The vehicles provided should be well-equipped with fire extinguishers, jacks and spare tires in cases of emergencies.
- vi) The company should be able to replace a vehicle as soon as required in case of breakdowns.

#### **DELIVERABLES**

- Provision of clean, roadworthy vehicles.
- Licensed and well-mannered drivers (certificate of good conduct).
- Safety, inspection and insurance compliance.

#### **GUIDELINES**

This call represents the requirements for an open and competitive process. It contains **two pre-qualification forms**, with instructions governing the applications to be submitted and the materials to be included therein; requirements that must be met for consideration; general evaluation criteria; and other requirements to be met.

All applications must be signed, dated, and stamped by an official agent or representative of the company interested. Companies that qualify to send their applications **MUST** be located or have operations within the specified coastal counties.

#### **APPLICATION SUBMISSION**

Interested and qualified service providers are required to submit an application that includes the following:

- i) Certification of registration/incorporation
- ii) Valid trade license
- iii) VAT certificate
- iv) PIN certificate
- v) Tax compliance certificate
- vi) Copies of audited financial statements for the last two years
- vii) CR 12 & CR 29
- viii) Insurance policies, e.g., workers' compensation insurance, etc.
- ix) Company profile and qualification of senior managers and all staff to be deployed.
- x) References from at least five companies /organizations, preferably NGOs, where similar car hire services have been or are provided by your company in the last two years, including customer name, official email, company address, and telephone number.
- xi) Complete detailed pricing proposal.

PRE-QUALIFICATION OF SUPPLIERS AND SERVICE PROVIDERS IN MOMBASA, TAITA TAVETA, TANA RIVER, LAMU, KILIFI, AND KWALE

GUIDELINES, CONDITIONS, AND APPLICATION

#### PART 1: CONDITIONS OF PRE-QUALIFICATION

#### 1. Introduction

Companies wishing to be considered for the supply and provision of car hire services to AIHD in the counties of Lamu, Mombasa, Tana River, Kilifi, Kwale, and Taita Taveta must first be prequalified.

Once pre-qualified, companies are subject to ongoing review by AIHD to ensure that the information submitted in their application remains valid and that they have performed satisfactorily when awarded contracts.

The purpose of the pre-qualification scheme is to minimize risks to AIHD and to reduce the effort of individual companies at the time of tender.

Companies will be required to comply with the Government of Kenya Statutory requirements.

#### 2. Pre-qualification Evaluation

All applicants will be evaluated based on their competence and financial capacity.

#### 3. Application for pre-qualification

Companies are invited to apply for pre-qualification by completing and submitting an application form, "Application for pre-qualification," and providing all information appropriate to the category being applied for.

#### 4. Assessment and Notification

Applications for pre-qualification will be assessed by a panel nominated by AIHD.

AIHD, its agents, contractors, or consultants may undertake investigations as necessary to assess performance and interview the applicant to clarify details of the application.

The criteria considered in the assessment of an application are listed in part 3: "information to be submitted with the application" of this document.

For each of the criteria, a company will be assessed as either:

- a) Not meeting requirements- below 75% of the total marks
- b) Acceptable standard- 75% and above

A company's score will be determined at the absolute discretion of AIHD.

A minimum score must be achieved by a company in each category.

Companies should allow at <u>least one week</u> from the deadline date of submission for the assessment process and will receive written notice of the outcome.

The pre-qualification of a company does not extend to related or subsidiary companies owned or controlled by the company.

#### 5. Pre-qualification Period, Renewal, and Upgrading

Pre-qualification granted under the terms of these guidelines is subject to Clause 6 'Reviewing, Rescinding or downgrading the Pre-qualification.'

Provisional pre-qualification may be granted in some circumstances, such as where a company does not fully comply with every requirement specified in this document, but the panel forms the reasonable opinion that the company will be able to do so in the near future (e.g., a new company has been formed which is staffed by experienced personnel). Full pre-qualification is then subject to the company demonstrating compliance with the requirements.

AIHD may make revisions to the scheme at any time and seek additional information from pre-qualified companies. AIHD may also place advertisements seeking new applications at any time.

#### 6. Reviewing, Rescinding, or Downgrading Pre-qualification

AIHD reserves the right to review the pre-qualification status of the company at any time.

AIHD may, in its absolute discretion, rescind the pre-qualification. Before such action is taken, the contractor will be given an opportunity to show cause why the pre-qualification should not be rescinded or reduced. The contractor will be given details of the matters prompting the request to show cause.

An assessment of a contractor's performance will be made against the pre-qualification criteria.

#### 7. Contractor to Advise

Pre-qualified companies are required to immediately advise AIHD of any significant change to their financial or technical capacity, ownership or holding, and any convictions/bankruptcy, or prohibition notices it may have.

#### 8. Confidentiality

AIHD will ensure the confidentiality of all information supplied by companies.
